



## End of pre-emptive rights offering period in Chile

Santiago, Chile. April 27, 2021.- Sociedad Química y Minera de Chile S.A. (SQM) (NYSE: SQM; Santiago Stock Exchange: SQM-B, SQM-A) announced the following information:

The mandatory 30-day pre-emptive rights offering period (the "Pre-emptive Rights Offering Period") for existing Chilean shareholders under Chilean law in relation to the capital increase approved at an extraordinary shareholders' meeting held by the Company on January 22, 2021 (the "Shareholders' Meeting"), ended on April 24, 2021. During this time, 22,441,932 new shares were offered to Series B shareholders or assignees of these shares at a preferred price of US\$50.00 per share. There is a remainder of 754,383 Series B shares that the Company's Board of Directors, in exercise of the powers conferred on it at the aforementioned Shareholders' Meeting, has resolved to place by means of one or more auctions to be carried out on the Santiago Stock Exchange on April 28, 2021. The shares may not be offered to third parties at values or conditions more favorable than those of the Pre-emptive Rights Offering Period to shareholders entitled to it, without prejudice to the provisions of the last paragraph of article 29 of the Public Limited Companies Regulations.

The brokers in charge of this placement are Larrain Vial S.A. Corredora de Bolsa, BTG Pactual Chile S.A. Stock Brokers and J.P. Morgan Corredores de Bolsa SpA.
