**Santiago, Chile. September 15, 2016.-** Sociedad Química y Minera de Chile S.A. (“**SQM**”) (NYSE: SQM; Santiago Stock Exchange: SQM-B, SQM-A) responds to an article that was published in the Chilean newspaper *La Segunda* on September 15, 2016. The article discusses an alleged investigation that was initiated by the Chilean Nuclear Energy Commission (*Comisión Chilena de Energía Nuclear*) (“**CCHEN**”) regarding SQM’s lithium exports.

Considering this, SQM outlines the following points:

1. According to a resolution adopted by CCHEN in the year 1995, SQM Salar S.A. (the “**Company**”) is authorized to produce and sell lithium according to the following conditions (the “**Conditions**”):
  - (a) A 30-year period starting with the first lithium sale;
  - (b) The total amount of lithium metal equivalent produced and sold should not exceed 180,100 MT; and
  - (c) Lithium cannot be transferred by the Company and cannot be used by anyone else for a final use related to nuclear fusion.
2. Since the resolution was adopted, CCHEN has been constantly checking the Company’s compliance with the conditions outlined above.
3. The Company has submitted all of the required information requested by to prove its compliance with the Conditions.
4. The Company has been in constant communication with CCHEN to respond to all of the requirements that could be required, and is in the process of officially responding to CCHEN following the article published in *La Segunda*.
