



SQM INFORMS ABOUT INVESTIGATION WITH THE ENVIRONMENTAL AUTHORITY

Santiago, Chile. June 8, 2016.- Sociedad Química y Minera de Chile S.A. (SQM) (NYSE: SQM; Santiago Stock Exchange: SQM-B, SQM-A) informs that the Environmental Authority (*La Superintendencia del Medio Ambiente*) (“SMA”) published a resolution yesterday regarding an analysis of SQM’s compliance with some information included in environmental permit (*Resolución de Calificación Ambiental*) number RCA 890/2010 associated with environmental plans in the Llamara area, which is located in the first region of Chile.

The document includes a series of observations, leading to eight different charges, which in general are related to certain variables regarding the monitoring plan and the implementation of the mitigation plan as proposed in the environmental study (*Estudio de Impacto Ambiental*).

SQM S.A. will respond accordingly to these observations and claims made by the SMA and if required, will implement all of the changes necessary to remain in compliance with the current environmental regulations.

SQM S.A. will continue to monitor the environment in the areas close to its operations, and will take all the necessary precautions to protect and sustain its operations.
